

# The Embodied Intuition Activation Terms & Conditions

## 1. Agreement to Terms

By enrolling in The Embodied Intuition Activation (the "Program"), you (the "Participant") acknowledge that you have read, understood, and agreed to these Terms & Conditions.

## 2. Program Overview

The Program is a guided mentorship designed to support Participants in deepening their intuitive abilities, emotional resilience, and embodied connection to self. The Program includes private mentorship sessions, integration support, and exclusive bonuses, as outlined in the Program description.

## 3. Payment & Enrollment

- 1. The first payment secures your spot in the Program.
